- ❖ We continue to investigate and work on an imposed tax from outside vendors taxing our community members a 3% sales tax. Our sales or use tax is not set up as simple as a 3% sales tax and is much more complicated. Our council will need to review chapter 4.20 Sales Tax.
- The Clerks and I have had an interested party to petition the current 8.15 Alcohol Delivery Site to a package store license (Municipal operated Liquor store).

## Facility Use:

- Piuraagvik
  - 1,9922 Customers with 0 private events
  - While our contractors where here looking into the flooring issues at Piuraagvik, they found additional damage. This additional damage included mold and water damage that spread underneath the floors.
  - We are at 100% on the design phase of the expansion and will be submitting reviews to the State Fire Marshals office for review.
  - In late September, we were able to apply tar to the roof to stop the leaking issues that were identified during the summer
- Roller Rink

- Youth Center
  - 475 Customers with 5 private events

We have been busy with building inspections and continue to conduct preventative maintenance in all the facilities. The new lighting for the shop has been installed and there is a significant difference in lighting. With winter here we are currently ensuring all facilities are ready.
